## Instructions:

The first owner of the calf should apply for its registration. These instructions are intended as a helpful overview; they do not replace or supersede the Rules or Bylaws. Refer to the Rules and/or Bylaws if necessary.

**Dam's Registration Number** – AAA assigned registry number. Please note number is from another breed association.

**Dam's Herd ID** – Suggest using the animal's individual number and year letter portion of its tattoo as the herd ID number. This is usually what a breeder puts on the tag to identify the animal. Limited to 8 characters. **Examples – 1Y or Annie**

**Dam's tattoo** is requested in order to confirm identity. If the dam is not a registered Aberdeen, indicate her breed using the codes below.

**Calf's Tattoo** should be applied before the application for registration is submitted.

Tattoo should include breeder herd letters, an individual number and the year letter. Please do not report a Brucellosis Vaccination tattoo. **Example: AAA1F**

Year letter codes are as follows: 2014 - B 2015 - C 2016 – D 2017 – E 2018 - F

**Mating Type: 1 – Artificial Insemination** requires an A.I. certificate if you are not the sire owner. A.I. certificates are electronic only. The sire owner contacts AAA and releases the electronic AI certificate on said bull where it is stored electronically in registering owner's inventory until said bull progeny is submitted for registration. **2 – Natural Service** requires a breeding service statement when owner of dam is not owner of bull. Natural service statement is available on the website or from the AAA Registry office. **3 – Embryo Transplant.** E.T calves require an A.I. certificate if you are not the sire owner. Also, a copy of the 'certificate of embryo recovery' should accompany E.T. registrations.

**Color Codes:** 1 = Black 2 = Red 3 = Gray 4 = Black w/white face 5 = Red w/white face 6 = Yellow/tan  
7 = Spotted/brindle 8 = White 9 = Other color

**Sire's Registration Number** - AAA assigned registry number.

**Sire's Name** is requested in order to confirm identity. If the Sire is not a registered Aberdeen, indicate his breed(s) using the codes above.

**Parent verification by DNA testing is required for Fullblood registrations. Please submit a copy of the DNA test results along with the registration application to the AAA Registry Office.**
